PROTOCOL FOR COLLABORATION WITH THE CIVIL SOCIETY WITHIN THE PROGRAM OPEN SPACE IN THE KINO KULTURA

The space of Kino Kultura (KK) is used by organizations from the civil sector as part of the OPEN SPACE program.

An OPEN SPACE is a program of KK that has been developed in collaboration with other organizations from the independent cultural scene and from the wider civil sector, individuals and informal groups. This program is open to various artistic and cultural contents, it is not regulated by a selection process, not defined by aesthetic criteria, nor by the curatorial concept. The KK recognizes associates and representatives of the cultural and art scene not only as users, but also as partners with whom together shape the development of the space and the scene itself.

This protocol means regulating our joint venture, which we agree to rely on the principles of democracy, equality, regularity, solidarity, mutual assistance, participation and respect for diversity. In the spirit of cooperation, we believe in ethical values - honesty, openness, transparency, social responsibility and care for others.

WHO AND ON WHICH CONDITIONS USES THE SPACE

1. Partners: organizations, informal groups and individuals

- Those who together with Kino Kultura develop a long-term program within the Open Space;
- Together invest different capacities in the development of the programs they implement (human, or technical, or financial) and the maintenance of the space;
- Their goal is for building and developing a space for critical reflection on social issues;

Terms of use

- Partner organizations have priority access to the space;
- Partners are part of the advisory body for the development of the program line- Open Space;
- Partners have an influence and a priority in deciding on the program they develop (for example children's theater, young people and theater, debate forums, etc.);
- Together with KK they promote programs;
- Together with KK they organize additional activities (cocktail):
- Together with KK organize security if necessary:
- Become partners with the invitation of the KK, if they want, that means voluntarily, and after having realized multiple positive cooperation with KK (2).

2. The wider civil society: organizations, informal groups and individuals

- Organizations dealing with culture and art, socio-cultural themes, and topics that concern the development of civil society, democracy and human rights;
- Have an interest in supporting and being part of the space where a critical reflection on social issues is being built;
- They are using the space of KK for realization of their own programs and activities.

Terms of use

- Getting the space for free use if it's not occupied;
- Cover the current costs of the space (electricity, technique and technical personnel, maintenance and hygiene) / the price is established depending on the type of the event, as well as the duration of the use of the space;
- Care for the promotion of their programs;

- KK promotes their programs through its communication mechanisms (Facebook, website, email);
- Organizing independently their accompanying activities (cocktail);
- Organizing the security if necessary;
- Signing a contract with a representative from the KK to use the space where the precise conditions are defined.

Kino Kultura DOES NOT SUPPORT hate speech, discrimination and violence on any ground.

Arbiter in case of dispute for all previously defined situations is the Governing body of the Kino Kultura composed of NGO Lokomotiva - Center for new initiatives in the arts and culture and the Association of the theater and educational works Theater Navigator Cvetko.
